## *Protection of Minors Policy & Procedures*

### ✓ *Requirements*

- All adults who work with minors are obliged to comply with these requirements:
  1. Be screened and **approved** by the National Responsible or locally appointed person(s)
  2. Pass a **background check** (including checks of criminal history and sex offender registry status)
  3. Complete VIRTUS **training** (The Protecting God's Children Program) and obtain the **Certificate of Completion** ([www.virtusonline.org](http://www.virtusonline.org))
  4. Read and sign the **Code of Conduct** (see Policy - Appendix B)
- VIRTUS Training must be renewed every 5 years; background checks every 6 years

### ✓ *Reporting Suspicions of Abuse*

- Report suspicions of child abuse to authorities

- Report to any of the following: the Policy Coordinator, a member of the Committee for the Protection of Minors, a member of the HAC Board, or the National Responsible (contact info on next page)
- NOTE THAT THE POLICY SUPPLEMENTS BUT DOES NOT REPLACE EXISTING MANDATORY CIVIL REPORTING OBLIGATIONS AS TO CHILD ABUSE
